

more than a week later, when the Las Vegas Metropolitan Police Department announced an undercover operation "targeting child sex predators". Alexandrovich was released and allowed to return to Israel after being charged with luring or attempting to lure a child online to engage in sexual conduct.

His release without travel restrictions has led to speculations that he may have received

preferential treatment due to the close ties between the US and Israel.




